We are grateful for your interest in Croatian euro coins.

For the purpose of the euro introduction Croatian National Bank prepared 420 million pieces of euro coins with the Croatian national side, as set out in the following table:

From the initial quantities of produced euro coins, 144.6 million pieces of coins were used to prepare 1.2 million of starter kits for citizens and 0.15 million starter kits for business entities.

A euro starter kit for consumers comprised 33 euro coins of all denominations, in the value of 13 euro and 28 cents, as set out in following table:
